
Zeta Theta House Corporation Update Planning for the Future

I am excited to announce that through a strong push at the end of last year we were able to hit our fundraising goal ending with \$11,550.95! We want to thank everyone that has been able to donate since the 55th anniversary. We wouldn't be able to do the work and renovations without this much needed support. This work ensures that the undergrads have the proper infrastructure and everything they need to be successful at school and to continue to hold up the strong reputation of Sigma Chi on the Kettering Campus.



We now set our sights to 2022. In order to reach this goal of \$15,500, we have officially kicked off the "1855 Club". This initiative consists of any brother who is donating a minimum of \$18.55 continually through at least 2023 (planning period). Currently we have 14 brothers that are members of this club, and they are denoted by the White Cross of Sigma Chi on the last page. We are currently putting together a number of prizes and benefits for these members. This includes free entry to the 60th anniversary, raffles, prizes, and more. Starting this year, House Corp will complete an annual report outlining our current financial state and plans for 2022. Below you can find this year's report. As many know, there had been a push to grow the endowment fund over the past several decades to help fund large projects. Now we face the challenge of growing this fund for two reasons. We need to be prepared for any unfortunate events which would result in the loss of our charter. Unfortunately, this has happened to other chapters for several different reasons. If this would occur, we would need to be able to maintain our costs for at least 5 years with no income. We estimate these costs to be upwards of one hundred fifty thousand dollars. We do not foresee this happening but must be prepared for worst case scenarios to protect the chapter house. Additionally, we are trying to prepare for some larger projects in the near and distant future, such as the kitchen refurbishment, new windows, fire escape, roof and more. This is the reason that the donations you provide are so important as they allow us to prepare properly for the future.
